ORDER

Submission Guidelines

All motions must be accompanied by supporting briefs and evidentiary submissions. Unless otherwise permitted, main briefs (in support or in opposition to a motion) shall be limited to twenty

(20) pages, doubled-spaced, using twelve point font. Reply briefs shall be limited to ten (10) pages, double-spaced, using twelve point font. Sur-reply briefs are not permitted, except by leave of Court. The Court will not look kindly on any attempts to circumvent the page limitations by manipulating type sizes, line spacing, etc.

Any evidentiary submission exceeding twenty pages must be indexed, tabbed, and bound so that the document will open flat. Evidentiary submissions shall not include copies of published cases or cases that appear on Lexis and/or Westlaw
